President Whitmore found a quorum and called the meeting to order at 9:00 a.m.

<u>Presentation and Report of Directors' Credentials for Delta, Eagle, Grand, Hinsdale, and Summit Counties.</u>

Andy Mueller reported that the executed credential for the directors from Delta County (Mark Roeber), Eagle County (Kathy Chandler-Henry), Grand County (Mike Ritschard), Hinsdale County (Stan Whinnery), and Summit County (Taylor Hawes) have been received by the River District. Director Ely moved, seconded by Director Curry, to accept the credentials as presented. Motion carried unanimously. (The credentials are attached as Appendices A-E).

Election of Board Officers for 2022.

Election of President:

Director Chandler-Henry moved, seconded by Director Hawes, to nominate Director Whitmore as president. Director Monger moved, seconded by Director Whinnery, to close nominations and elect Director Whitmore as president for 2022. Motion carried unanimously.

Director Curry moved, seconded by Director Whinnery, to close nominations and elect Director Chandler-Henry as vice president for 2022. Motion carried unanimously.

Adoption of Resolution for Outgoing Directors.

President Whitmore presented, for Board approval, a resolution commending outgoing Delta County Director, Thomas Alvey, for his thirteen years of service to the Colorado River Water Conservation District, Delta County, and its water users. Director Gray moved, seconded by Director Beckley, to approve the resolution. Motion carried unanimously.

General Manager's Report.

Roundtable Appointments for Yampa-White-Green and Southwest Basin Roundtables.

Director Gray moved, seconded by Director Hawes, to appoint Mike Eytel as the River District Representative to the Yampa-White-Green Roundtable; and Dave Kanzer as the River District Representative to the Southwest Basin Roundtable. Motion carried unanimously.

Zane Kessler presented the following bills for action:

HB22-1001: Concerning Wildfire Mitigation Incentives for Local Governments.

Recommendation: Support.

After discussion by the directors, President Whitmore directed staff to bring this item back at the next board meeting for further discussion and action.

HB22-028: Concerning Groundwater Compact Compliance Fund.

Recommendation: Support.

Director Curry moved, seconded by Director Chandler-Henry, to support HB22-028. Motion carried unanimously.

SB22-030: Concerning Water Resources Review Committee to Include Agriculture.

Recommendation: Monitor.

Director Hazard moved, seconded by Director Whinnery, to monitor SB22-030. Motion carried unanimously.

SB22-029: Concerning Investment Water Speculation.

Recommendation: Amend.

Director Chandler-Henry moved, seconded by Director Beckley, to amend SB22-029. The motion passed 8:5; Directors McInnis, Gray, Ely, Vanden Brink, and Hazard voting against. Director Whinnery did not vote; and Director Catlin was not present. President Whitmore directed staff to bring this bill back at the next board meeting for further discussion.

Project Operations and Updates (Enterprise Matters).

Approval of Contract with Advanced Terra Testing, Inc.

Director Ritschard moved, seconded by Director Monger, to approve the General Manager, after review and approval by counsel, to execute a contract with Advanced Terra Testing, Inc. in an amount not to exceed \$100,000 for geotechnical laboratory testing. Motion carried unanimously.

Ruedi Reservoir.

Andy Mueller requested the Board waive the \$400 application fee as requested by the CWCB for its 1,750 acre-foot contract from Ruedi Reservoir for anchor ice mitigation and enhanced flows in the 15-mile reach. Director Hawes moved, seconded by Director Roeber, to waive the \$400 application fee as requested. Motion
